Per 100 ml

Chlorpheniramine Maleate.....3mg

Dipotassium Glycyrrhizinate.....25mg

ε-Aminocaproic Acid.....150mg

Pyridoxine Hydrochloride (vitamin B₆)10mg

Taurine.....100mg

Additives: Boric Acid, Sodium Borate, Edetate Sodium, Glycerin, Propylene Glycol, Polysorbate 80, Benzalkonium Chloride Concentrated Solution 50, l-Menthol, dl-Camphor, d-borneol, pH adjuster

Storage and Handling Precautions

- (1) Store tightly closed in a cool place and out of direct sunlight.
- (2) Keep out of reach of children.
- (3) Don't put it in a different container. (It can lead to misuse or lowering of quality.)
- (4) Please do not share the eye wash cup with others.
- (5) Please do not use medicine after the expiration date.

Indications

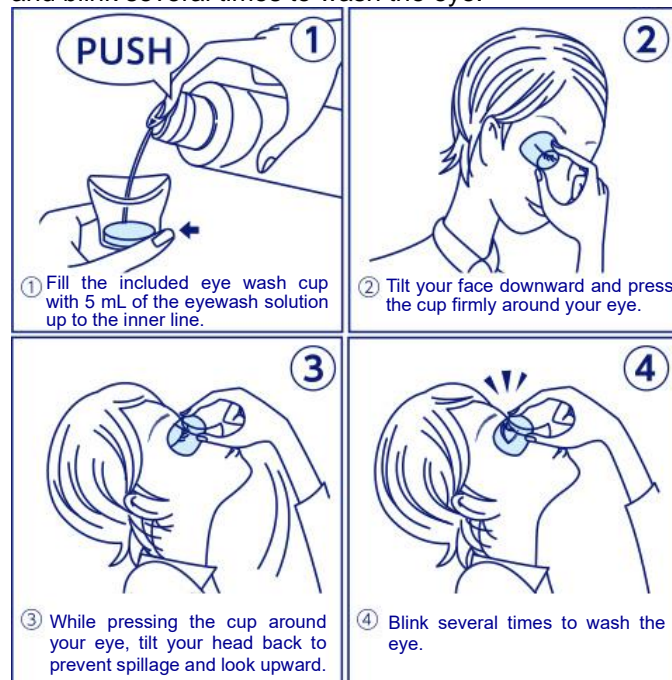
Eye cleansing, prevention of eye diseases (After swimming, when dust or sweat gets into your eyes, etc.)

Dosage and Administration

Use 3 to 6 times a day. Wash the eyes with 5 mL of this product each time.

<How to Use>

Fill the included eye wash cup with the eyewash solution up to the inner line (5mL) and press it firmly around your eye. Then, while keeping the cup pressed around your eye, tilt your head back to prevent spillage, look upward, and blink several times to wash the eye.



Do not wash the other eye with the same liquid used for one eye. Dispose of the liquid, thoroughly clean the eye wash cup with tap water, and then wash the other eye.

<Precautions related to dosage and administration>

- (1) Follow the Dosage and Administration strictly.
- (2) For children, please follow the guidance of a guardian when using this product.
- (3) Do not use this product while wearing contact lenses.
- (4) Please thoroughly clean the eye wash cup with tap water before and after use.
- (5) Do not use it if the solution is cloudy.
- (6) Use only for eye washing.
- (7) Please cleanse the area around the eyes and remove makeup thoroughly before use.
